Activities under entitlements focusing on NSAP and PRI-CBO Convergence

- a. Create awareness and provide support in accessing atleast one insurance (either person or livestock) for every household
- b. Create awareness and provide support in accessing pensions as per eligibility (old age pension, widow pension and persons with disability pension)
- c. Provide capacity building to all SHG women to motivate them to actively participate in Gram Sabhas and in Gram Panchayat planning.

Activities under livelihoods:

- a. Formation of labour groups
- b. Create awareness on job card and support in accessing 100 days of work under NREGS.
- c. Accessing unemployment allowance to members having a job card and demanded work.

Sanjeevini KSRLM has chosen 673 villages in 146 Gram Panchayats in 4 talukas to implement the convergence project. The chosen project area expanse covers a total of 1,91,432 households of which 86, 786 households will be targeted (having atleast 1 deprivation criteria as per SECC)
