
Subject: Visits of National Level Monitors (NLMs) to districts for monitoring of the Nirmal Bharat Abhiyan in selected States and Districts.


2. It is requested that concerned officers in the selected districts, dealing with the NBA may be advised to make necessary arrangements for local travel to the GPs to be visited by the Monitors (within the district) and lodging arrangements for the NLM team.
3. Each team to a district will comprise of 2 members and will be staying in the district for 3 days. The NLMs have been advised to contact the respective State and district NBA Coordinators and intimate them of their travel programme.

CIRCULAR

Sub: Visit of National Level Monitors (NLMs) to the States/Districts-Advisory to States/districts

Instances have come to the notice of the Ministry where some persons claiming to be National Level Monitors (NLMs) of this Ministry demanding favors like air/rail tickets, hotel accommodation etc. from District Administrations. In order to prevent such fraudulent practices, the State Governments/UT Administration and the District Authorities are advised to be extremely vigilant.

2. All the State/District Authorities and Programme Implementing Agencies concerned with the programmes of this Ministry may note the following:

- i) List of NLMs empanelled by the Ministry of Rural Development is available on the website of the Ministry (www.rural.nic.in) under the link 'NLM'.
- ii) NLMs are paid TA/DA and other monitoring charges by the Ministry of Rural Development in accordance with the guidelines. As such, no expenses are to be borne by the State/district towards these items.
- iii) NLMs are expected to bear the cost of boarding/lodging and travel themselves. In case subsidized (or free) lodging/travel facility is provided to NLMs, District Administration may issue a certificate to NLMs to that effect, indicating the details and with a copy endorsed to this Ministry. In case subsidized (or free) lodging/travel facility is not provided, a certificate to that effect may be issued to NLMs, if they request.
- iv) **Wherever NLM(s) is deputed to any district, a copy of the assignment letter will be endorsed to the District Collector and the Programme Implementing Agency. Information of such deputation will also be posted on the website of the Ministry under the link "NLM" simultaneously. The District Administration should verify the fact of deputation by cross checking with the website before taking further action. The District Administration should also verify the identity of the NLM through the Identity Card issued to them by the Ministry of Rural Development.**
- v) In case of any undesirable action by any of the NLM(s), the same should be brought to the notice of the Ministry indicating the details.

3. Secretaries in charge of the programmes of this Ministry in all the States/UTs and the District Administration/Programme Implementing Agencies are requested to ensure that the above advisory is strictly followed while entertaining NLMs.

Subject: Visit of National Level Monitors (NLMs) to districts for Special Monitoring of the Nirmal Bharat Abhiyan (NBA) (February - March 2014)

Sir/Madam,

The Ministry of Drinking Water and Sanitation has decided to conduct Special Monitoring of the NBA during February - March, 2014.

Accordingly, you have been assigned **Districts of State**

Formats for data collection along with instructions and the list of 12 GPs (district-wise) are uploaded on NLM Online System. You may carry sufficient number of copies of formats before proceeding to the districts.

2. The Principal Secretary/Secretary in-charge of the implementation of NBA, in the State concerned is being advised separately to instruct the district authorities to facilitate your visit. You are required to contact State NBA Coordinator/ District NBA Coordinator of the district concerned and inform them about your visit. List of contact persons is available at <http://www.tsc.gov.in>.


3. Each NLM will have to cover One State, 3 districts in the State and 2 GPs each in 3 selected Blocks in a district. The 6 GPs in each district will have to be selected strictly from the list of 12 GPs provided to you. Institutional NLMs are to depute two persons for carrying out the field work. **During the field visits, the NLMs should do thorough and logical probing to get to the realities existing in the field, which will have to be reflected in the district reports in a meaningful way so that to ensure qualitative value to the Reports.**

4. You are requested to proceed for the field work immediately after the receipt of formats for data collection and complete the assignment by **28th February, 2014**. Online data entry will have to be completed latest by **2nd March, 2014**

5. The District Reports (3 Copies) should reach this Ministry by **15th March, 2014**. **The soft copies of the Reports are also to be furnished to the Ministry through email at ruralmonitor@gmail.com as pdf file attachment. Reports received after the due date will not be entertained, except in rarest of rare cases, for which prior approval of the Ministry is to be obtained.** The Reports should invariably contain relevant photographs, in addition to proper texts.

6. The claim of TA/DA etc. would be governed by the terms & conditions of the guidelines of NLM. The expenditure towards travelling to districts should be initially borne by you and the admissible amount will be reimbursed to you on submission of TA Claim Bills in Triplicate (three sets) with revenue stamps affixed thereon in the prescribed format, used for NLM visits of MoRD.
