Subject – Central Assistance to District Rural Development Agencies in the State of **Karnataka** for the year 2014-15 under DRDA Administration Scheme – Release of 1st & 2nd instalment.

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs. 1,62,68,000/- (Rupees One Crore, Sixty Two Lakh and Sixty Eight Thousand Only)** to the State Government of **Karnataka** towards **1st & 2nd instalment** of Central share for implementation of the DRDA Administration Scheme for the financial year 2014-15, to the DRDAs as per details given in Annexure.

2. The release is subject to the following conditions:-

- (a) The State Government must transfer these funds to the CEO, Zilla Panchayat/Project Director, DRDA immediately. The State Government is requested to endorse a copy of the release order within 3 days to the Central Government addressed as under;

- (b) The quantum of release is subject to actual requirement within the overall ceiling.
(c) The funds shall be utilized for meeting the cost of salary and contingent expenditure only
(d) The funds would not be diverted to any purpose other than meeting the salary and contingent expenditure as per the Guidelines of the Scheme.
(e) The State Government should release its contribution towards the overall cost of DRDA Administration. Deficiency in release of State share shall be deducted from the 2nd instalment of funds during 2015-16.
4. The funding pattern under the scheme will be 75:25 between Centre and the State. The Utilization of funds should be in accordance with the DRDA Administration guidelines.

5. The accounts of the grantee institutions/DRDAs will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 211 (1) and 211 (2) of the General Financial Rules.
6. No Utilization Certificate is pending against the concerned District Rural Development Agency.
7. The expenditure is debit to the following Head of Accounts under Demand No. 84 Department of Rural Development (2014-2015).

3601- Grants-in-Aid to State Govt. (Major Head)
02 - Grants for State Plan Schemes (Sub-Major Head)
