NOTIFICATION

The draft of the following rules further to amend the Karnataka General Service (Development Branch and Local Government Branch) (Cadre and Recruitment) Rules, 2008, which the Government of Karnataka proposes to make in exercise of the powers conferred by sub-section (1) of section 3 read with Section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) is hereby published as required by clause (a) of sub-section (2) of section 3 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration after fifteen days from the date of its publication in the Official Gazette.

Any objection or suggestion, which may be received by the State Government from any person with respect to the said draft before the expiry of the period specified above, will be considered by the State Government. DRAFT RULES

1. **Title and commencement:-** (1) These rules may be called the Karnataka General Service (Development Branch and Local Government Branch) (Cadre and Recruitment) (Amendment) Rules, 2014.

(2) They shall come into force from the date of publication in the Official Gazette.

2. **Amendment of the Schedule:-** In the Karnataka General Service (Development Branch and Local Government Branch) (Cadre and Recruitment) Rules, 2008, in the schedule, in the entries relating to the category of post of "Executive Officer, Panchayat Raj / Assistant Secretary, Panchayat Raj" at serial number 5, in column 5, under heading "For Promotion" for the first proviso the following shall be substituted, namely:-

"Provided that, for a further period of one year from the date of commencement of Karnataka General Service (Development Branch and Local Government Branch) (Cadre and Recruitment) (Amendment) Rules, 2014, if a person who has put in a service of not less than three years is not

available, a person who has put in a service of not less than one year may be considered for promotion”
