Ministry of Rural Development, New Delhi has sanctioned and released 1st instalment amount of Rs. 22,46,03,169/- to 7 projects for Training and Placement Projects under centrally sponsored "Aajeevika Skills" programme submitted by the 7 Project Implementing Agencies (PIAs) for implementation in Ref 1 to 7 through the Central Technical Support Agency - National Institute of Rural Development (NIRD), Hyderabad. Accordingly the State Government has to release its 25 % share

amounting to **Rs.7,48,67,724/- (Rs.Seven Crore Forty Eight Lakh Sixty Seven thousand and Seven hundred Twentyfour only)** to NIRD, Hyderabad for releasing it to the following 7 PIA's

But the KSRLPS in O.M. dated 28.03.2014 in Ref-8 had released Ist Instalment State Share of Rs.9,21,71,100/- to NIRD, Hyderabad for releasing to 8 PIA's. NIRD, Hyderabad has released the State share of Rs.6,28,55,600/- to 7 PIAs who have entered into MoU. But IL & FS Education and Technology Services Limited, Mumbai has not still entered in to MoU. They have submitted proposal to Ministry of Rural Development to implement the scheme through IL & FS Skill Development Corporation Ltd.(ISDC) which is a subsidiary company of IL & FS Education and Technology Services Limited. The proposal is pending for approval with Ministry of Rural Development, NewDelhi. Hence amount of Rs.2,93,15,500/- is still with NIRD, Hyderabad.

In the Circumstances, it is approved to release balance State share amount of **Rs.4,55,52,224/- (Rs.Four Crore Fiftyfive Lakh Fiftytwo Thousand Two Hundred and Twenty Four only)** to NIRD, Hyderabad for releasing to the above 7 PIAs through RTGS as follows :
