The Empowered Committee on Aajeevika Skills Projects held in the Ministry of Rural Development, New Delhi on 22-10-2013 has approved 9 projects under centrally sponsored Skills Training and Placement Special Projects submitted by the Project Implementing Agencies (PIAs) for implementation in Karnataka dated 30-10-2013 (Ref.1). The Ministry of Rural Development has sanctioned and released 1<sup>st</sup> instalment amount of Rs.27,65,14,398/- .to 8 PIAs out of 9 PIAs (Ref 2 to 9) through the Technical Support
